GENERAL TERMS:

1. The Image Bank of the Museo Nacional del Prado is entrusted with the exclusive administration of all the Museo del Prado's images reproduction rights to disseminate and/or publish, wholly or partly reproduce, distribute, publicly communicate and transform graphic, bibliographic, phonographic, audiovisual, telematic, multimedia or computer items, into any medium or format including those of radio-broadcasting or re-broadcasting, all in either analogue or digital modalities. It also manages all the images administration of reproduction rights in all commercialization systems.
2. Prior to the making of a reproduction, the user must request the opportune authorization from the owners of the exploitation rights set out in article 17 of the Legislative Royal Decree 1/1996, of April 1, whereby the consolidated text of the Intellectual Property Act is passed into law.
3. The Prado Museum Image Bank is not responsible for the use that may be made of the reproductions contrary to the Intellectual Property Act and/or any other legal provision.
4. The following is prohibited: the utilisation of the images for any purpose (not just of a commercial or advertising nature) without authorisation from Museo Nacional del Prado Difusión; the reproduction, distribution or transformation thereof without the authorisation of their legitimate owners. The reproduction authorisation does not confer any intellectual or industrial property right.
5. Responsibility for the use of images from the Museo del Prado web site. It is prohibited to reproduce, distribute or transform these without authorisation from their legitimate owner: Museo Nacional del Prado and, as commissioned, Museo Nacional del Prado Difusión.
6. The client makes a commitment to the form of use specified in this agreement. The parties agree that should there be any form of use other than that which is authorised, or a modification of the terms of use (specified in the sections: medium, territory, language, size or edition), with prior authorisation, the user will pay Museo Nacional del Prado Difusión triple the sum that applies in accordance with the relevant charges as a penalty clause.
7. Liability for the prohibited acts: The users, without authorisation, who utilise the images or reproduce, distribute or transform them without having said due authorisation, will be bound to pay triple the sum of the announced charge and that would have been required of it in granting the authorisation, as consideration, as an indemnity for damages occasioned. The same sum will be demanded from those that utilise the images for purposes other than those authorised or carry out acts that are not covered in said authorisation. Should the payment of the amounts stated not be applicable, the opportune legal actions will be exercised.
8. The assigning of the reproduction and publication rights of the images is not exclusive and the Image bank of the Museo del Prado has the complete option to grant the same rights to interested third parties. The right of reproduction will not be granted upon payment to the Museo Nacional del Prado Difusión.
